Sub: Request to furnish information under RTI Act 2005.

Sir,

The Under Secretary (SEA) addressed a letter to Karnataka, Kerala, Punjab and West Bengal vide No. 33-04/2016-SEA.III dated 16/06/2017 stating that "UDCs absorbed as Sr. Accountants may be reverted to the post of Jr. Accountants with effect from the date of their absorption as Sr. Accountant. In this connection it is requested to furnish the following information under RTI Act 2005.

- 1) Copy of the orders and name and designation of the officer (who took such decision) exempting other circles from implementing the above referred order except the four circles viz; Karnataka, Kerala, Punjab and West Bengal as the same order has not been sent to other circles.
- 2) We procured under RTI Act from the O/o CCAs viz; TN Circle, Guwahati, Bihar Circles that in those circles also UDCs were absorbed as Senior Accountants. Copy of the orders in which the above orders are not sent to those circles along with name and designation of the officer who took the decision.
- 3) In Chhattisgarh and Andhra Pradesh Circles SI (Ministerial) from para-military forces were also absorbed as Sr. Accountants. According to the Establishment Manual of CRPF (copy enclosed) the SI (M) is equivalent to the post of UDC. The copy of orders for non-

reversion of those SI (M) to the post of Jr. Accountant from their date of absorption.


- 4) As per page Nos.5 & 6 of Annexure E of the report of the Committee appointed on absorption only those candidates who are working in the organized accounts cadre employees are to be absorbed as Sr. Accountants, however, as per the information furnished by some circles, employees from the categories of Stenos, Data Entry Operators, Crime Assistants, Chageman, Head Clerk, Assistants from GCS cadre, Assistants from CSS cadre etc. from non-analogous cadres and from the employees of PSUs, Corporations are also absorbed as Sr. Accountants. The copy of orders to continue them without reversion in violation of notification or Recruitment and as per the above orders of US(SEA)
- 5) A copy of the orders to continue the wrongly absorbed Jr. Accountants from the cadres of Stenos, Data Entry Operators, employees not having minimum 8 years service in the LDC cadre in the parent department as required under notification.
