Shri A.K.Ambade may join the duties within twenty days as a Consultant in APAR Section, (DoT) after giving acceptance for the same, if the terms & conditions and remuneration mentioned above are acceptable to him from the date of issue of the order failing which it would be presumed that the officer is not interested to join in APAR Section, DoT as consultant and the offer treated as cancelled.
- 6. The engagement of Shri A.K.Ambade can be terminated at any time without assigning any reason whatsoever. However, if the Consultant is not willing to continue for whatsoever reasons may be, he may give minimum one month's notice to the office. The decision of Member (Services), Telecom Commission, Department of Telecommunication shall be final in all respects.
