The undersigned is directed to forward herewith the dossier(s) of \_\_\_\_\_ candidates nominated by SSC for appointment as Junior Accountant in the Department of Telecommunications and allotted to your circle by the Competent Authority.

- 2. As per directions of SSC, the Appointing Authority should verify the following particulars/documents of each of the candidate prior to issuing offer of appointment to him/her:-
  - (i) Date of Birth
  - (ii) Essential Qualification as on crucial date (i.e. <u>01.01.2016</u>)
  - (iii) Age Relaxation claimed by the candidate
  - (iv) SC/ST/OBC/Ex.S certificate issued by the Competent Authority
  - (v) In respect of OBC candidates, the extant guidelines regarding creamy layer status may be followed strictly
  - (vi) The genuineness of OBC certificate indicating Non-creamy layer status by the prescribed authorities need to be verified in case of OBC candidates who have been selected on a provisional basis
  - (vii) The eligibility of candidates whose candidature has been kept provisional for reasons other than OBC status should be verified.
  - (viii) Candidate's result, rank, category etc. may be verified with the result available on the commission's website and the list enclosed.
  - (ix) Photo, Signature, LTI and Handwriting taken on Admission certificate (Commission's Copy) and documents obtained at different stages of Examination need to be verified with those the candidate may actually submit at the time of joining the service.
- 3. In addition, pre-appointment formalities such as Character and Antecedant Verification & Medical Examination, etc. of the candidate may also be completed as per extant Rules and Regulations.

- 4. Any person who claims to belong to a Scheduled Caste or a Scheduled Tribe or Other Backward Class will have to produce a certificate to the Appointing Authority/Selection Committee/Board etc. in support of his claim so as to make him eligible for reservation and various relaxations and concessions. The Appointing Authorities should verify the caste status of a Scheduled Caste/Scheduled Tribe/Other Backward Class candidate at the time of initial appointment against reserved vacancies. For this purpose, the caste and the community to which an SC/ST/OBC person belongs, his place of residence and the name of the State, should be pasted on the top of his service book, personal file or any other relevant document to facilitate such verification. It may be noted that a Scheduled Caste person, whose caste has been de-scheduled after his initial appointment as a Scheduled Caste, is no longer entitled to enjoy the benefit of reservation in promotions.
- 5. If any candidate declines the offer of appointment or fails to report for duty, or there is no response from him/her even after reminder(s) (through speed post/registered post with acknowledgement due), the offer of appointment should formally be cancelled and the candidate informed accordingly. The dossier of such a candidate may thereafter be returned to the commission after placing therein a copy each of the offer of appointment, subsequent reminder(s) and the memorandum of cancellation of the offer of appointment.
- 6. The appointment letters to the nominated candidates shall contain the following condition:

"The appointment of these candidates shall be subject to the final outcome of the Writ Petition to be filed by the Commission before the Hon'ble High Court of Delhi against the order dated 23.10.2017 passed by the Learned. CAT, Principal Bench, New Delhi in OA No. 2964/2017 filled by Shri Rohit Kumar and Ors/any other litigation (OAs/WPs/SLPs), as the case may be"

7. The process for issuing appointment letters to the candidates may be initiated as early as possible.

The task may be taken on top priority. Compliance report may be sent to this office.
