





Central Electricity Authority (CEA) is a statutory body originally constituted under section 3(1) of the repealed Electricity (Supply) Act, 1948, since substituted by Section 70 of the Electricity Act, 2003 (36 of 2003) to carry out functions as defined in the Act. The post of Member in the Central Electricity Authority, New Delhi, an attached office of the Ministry of Power carries in Level-15 in pay matrix/(Rs. 1,82,200-2,24,100)/(67000-79000)(pre-revised) with ex-officio status of Additional Secretary to the Government of India. The incumbent of the post is entitled to other allowances/benefits as per rules of the Central Government. 




