
ORDER

2. On promotion, the officer will report to DoT Hqs. for further posting on promotion.

Further if the officer assumes charge of the higher post within six months from the date of the promotion order or before the last person borne on the panel is offered promotion without being required to be reassessed by a fresh DPC whichever is later, the officer will not be required to be considered afresh by the next DPC and the officer will retain her seniority as per the position in the panel. If however, the officer does not join within the period as specified above and continues to remain on long leave or seeks further extension of leave, the order of promotion will become invalid and the officer will be required to be considered afresh by the next DPC held in the normal course after she joins her duty on expiry of the leave
4. The officer will be entitled to exercise an option towards fixation of pay as available under FR-22.
