OFFICE MEMORANDUM

Subject :- Looking after for head of LSA till the posting of regular HAG/HAG + officers.

As per DoT's Office Memo No.9-5(1)/2016-Estt. Dated 23.02.2017, an integrated HR set-up in the 22 Licensed Service Areas(LSAs) have been approved. The set-up in the LSAs will be headed by one HAG Plus/HAG officers reporting to DG Telecom.


2. The organization structure of LSA and break up of officers to be posted in these LSAs and given Annexure-II and Annexure-III of the said O.M. Each LSAs will have 5 or more verticals headed by DDGs under the control of an LSA head. 6 LSAs are headed by HAG+officers and remaining 16 are to be headed by HAG officers.

3. I am directed to convey the approval of the competent authority that the senior-most officer posted at LSA headquarter shall now perform the duty(ies) of LSA head with look after charge of Sr.DDG without any extra remuneration or any claim on this account until further orders or until the regular officer joins his duties as LSA head, whichever is earlier.

4. Presently, following officers are senior-most officers posted in LSA headquarters, and are designated as Sr.DDG as per terms para-3, above :-
