**ORDER**



- (i) Final order issued vide order No. 8-104/2003-Vig.II dated 22-08-2005 imposing a penalty of reduction by three stage in the time scale of pay for a period of three years with further direction that he will not earn any increment during the period of such reduction and on the expiry of such period, the reduction will have the effect of postponing his future increments of pay as per RDA No. 3-18/2000-VM.III dated 17-03-2003.
- (ii) Final order issued vide 8-29/2004-Vig.II date 03.2.2004 imposing a penalty of reduction by one stage for 02 years without cumulative effect, against RDA No. 3-10/2001-VM.III dated 03.02.2004.
- (iii) Final Order issued vide 8-69/2009-VIG.II dated 31.01.2018 imposing a penalty of withholding of 25% of monthly pension for five years, as per RDA No. 9-19/2008-Vig.I dated 08.12.2009. VC is granted with a request to read the DoB as corrected to 18.06.1955.
