- 4. The expenditure will be debitable to the Major Head "34510009101-DoT,0028-Professional Service' and may be met from the budget grant of the concerned financial years.
- 5. Shri D.K.Jain may join the duties within twenty days as a Consultant in IR Wing, (DoT) after giving acceptance for the same, if the terms & conditions and remuneration mentioned above are acceptable to him from the date of issue of the order failing which it would be presumed that the officer is not interested to join in IR Wing, DoT as consultant and the offer will be treated as cancelled.
- 6. The engagement of Shri D.K.Jain can be terminated at any time without assigning any reason whatsoever. However, if the Consultant is not willing to continue for whatsoever reasons may be, he may give minimum one month's notice to the office. The decision of Member (Services), Telecom Commission, Department of Telecommunication shall be final in all respects.
