

be done as per the provisions of CCS (RP) Rules, 2008. At the time of regular promotion to this grade, the pay need not be fixed again for the officers who have been granted up-gradation under these orders.

4. The above promotion order is being issued after obtaining the vigilance clearance from the Vigilance branch, DoT HQ. However, in case it comes to the notice of the Controlling Authority that any disciplinary/prosecution case is pending against the officer or the officer is under suspension, or any punishment of stoppage of increment etc is in operation against the officer, he should not be promoted without obtaining the specific approval of this Department. 
