



Consequent upon the amalgamation of the IP&T AFS Group 'B' cadre of the Deptt. Of Posts and the Deptt. Of telecommunications w.e.f. 1.9.2009 vide Gazette Notification No.2198 (E) dated 20.08.2009, the AAOs from Department of Posts who were working on deputation in DOT were retained in the same grade on as-is where-is basis vide DoT Order No.27-1/2009-SEA-II dated 31.8.2009 w.e.f. 1.9.2009. The case of protection of last pay drawn by such officials of IP&T AFS group 'B' w.e.f. 1.9.09 has been under consideration in accordance with FR.22.

It has now been decided by the Competent Authority to extend the protection of last pay drawn to all those AAOs who were on deputation from Department of Posts and working in IP&T AFS Group 'B' in DOT on 01.09.2009.

This issues with the approval of Member (F), Telecom Commission vide their diary No. 373 Member(F)/11 dated 15.3.11.

Respected Sir,

Most humbly and respectfully, I wish to put forth that the DOT New Delhi vide their OM No. 25-1/2010/SEA-II dtd. 30-03-2011 (Annexed) decided to extend the protection of last pay drawn to all those AAOs who were on deputation from DOP to DOT and working as JAOs/AAOs on 01-09-2009 under FR-22, taking in to account their past services rendered by them in DoT as such, on regular promotion in these Deptts. in the wake of amalgamation of the Finance and Accounts service Gr 'B'.

In this context, I am to humbly submit that I too had worked as JAO in the DOT on deputation basis from Deptt. of Posts from 07.09.1994 to 14.09.1997.

I drew pay & allowances during my said deputation in Department of Telecom from 07-09-1994 to 31-12-1995 in the pre-revised pay scale of Rs.1640-60-2600-EB-75-2900 revised as Rs. 6500-200-10500, On implementation of Vth Central pay Commission with effect from 1.1.1996. Accordingly I have drawn pay & Allowances as particularised below with DNI Ist of Sep. every year:-

(I)	07-09-1994 to 31-08-1995	Rs.1640
(II)	01-09-1995 to 31-12-1995	Rs.1700
(III)	01-01-1996 to 31-08-1996	Rs.6500
(iv)	01-09-1996 to 31-08-1997	Rs.6700
(v)	01-09-1997 to 14-09-1997	Rs.6900

On repatriation from deputation I was promoted as JAO on adhoc basis w.e.f. 20-11-1997 and my pay was fixed at the stage of Rs. 6500 in the pay scale of 6500-200-10500 vide No. Admn I/A-IV/ BPL/97-98/712 dtd. 19-11-1997 while it should have been fixed at the stage of Rs.6900/- (as drawn earlier as JAO on deputation to DOT ) ignoring my previous services rendered in the same cadre on deputation to Telecom Department. However, no pay protection was afforded to me to save from the financial loss as has been done in the cases covered under orders dated 30.03.2011 ibid.

It perhaps needs no mention here that JAO cadre was re-designated as AAO vide Govt. of India notification dated 25.06.2009. Further vide ADG (SEA) OM No. 25-1/2010/SEA-II dated 30.03.2011, it has been decided to extend the protection of last pay drawn to all those AAOs who were on deputation and working in IP&T AFS Gr.-B in DoT upto 01.09.2009. Had the same benefit been extended to me also, my pay from time to time would have been as under-

Whatever justification existed for the officers as on 01.09.2009 existed while issuing orders dated 30.03.2011 *ibid*, the same are equally might have been available in our cases too for the pay protection, on return from DoT deputationist.



Instead, the DoT (HQ) seems to have taken up for protection of last pay drawn in advertently only for those AAO's who were on deputation on a particular day i.e. 01-09-2009. It is worth mentioning here that all rules/instructions framed under Fundamental Rules and service Rules need to be made applicable to all the officials who were on deputation irrespective of date of their repatriation or otherwise. There should not have been any targeted date for this benefit. Prescribing any particular day for this purpose violates the provisions of articles 14 & 16 of the Constitution Of India, which ensures provisions of equal opportunities for all, and equal pay for the equal work .

It is evident that the provisions of the aforesaid OM dt 30-03-11 created a lot of disparity in respect of those deputationist who were repatriated prior to the stipulated date i.e. on 01-09-2009 and later on promoted as AAO in their parent Deptt. i.e. Department of Posts. The orders dated 30-03-2011 are against the principles of equality as enunciated in the constitution. These orders deprived me the benefit of protection of last pay drawn. It is needless to humbly point out that my services also have come under I P&T AFS Gr. 'B' cadre (ie. under the same Ministry in which others particularly DOT deputationist worked as on the said date of 01-09-2009 after amalgamation of IP&T AFS Group 'B' cadre of the Deptt. of Posts and Deptt. of Telecommunication) on the very day of 01-09-2009 itself.

Due to non protection of my pay at the time of promotion as JAO (now AAO) on 20-11-1997, it caused severe, permanent and perpetual financial loss which will ultimately effect my pensionary benefits too.

I therefore, request your honour to kindly consider my case for the protection of last pay drawn at the time of repatriation from DoT on completion of deputation and provide the same pay of Rs. 6900 from date of promotion as JAO ie, w.e.f. 20-11-1997 in the Postal Deptt. followed by regular promotion on 01-01-08 under FR-22 on the similar lines as ordered by DOT H.qtrs. OM dated 30-03-11, so that I may not suffer financially on the fagend of my service career. It is needless to say that I am now to retire on superannuation in next year 2017 and if this anomaly is allowed to persist I will be suffering from a huge financial loss on account of retiral benefits as well as the admissible pension/family pension etc.

I therefore humbly again request your good self. kindly to provide me immediate redressal as requested in pre-para so that I may be saved from perpetual pecuniary loss. I shall be highly obliged for this act of kindness.





Most humbly and respectfully, I wish to draw your kind attention towards my representation dated 25-04-2016 on the subject cited above. In this context by I once again request your good self kindly to get examine and decide it favourably at the earliest possible on the following grounds which I had already mentioned in my earliest representation –

I drew pay & allowances during my said deputation in Department of Telecom from 07-09-1994 to 31-12-1995 in the pre-revised pay scale of Rs.1640-60-2600-EB-75-2900 revised as Rs. 6500-200-10500, On implementation of Vth Central pay Commission with effect from 1.1.1996. Accordingly I have drawn pay & Allowances as particularised below with DNI Ist of Sep. every year:-

On repatriation from deputation I was promoted as JAO on adhoc basis w.e.f. 20-11-1997 and my pay was fixed at the stage of Rs. 6500 in the pay scale of 6500-200-10500 vide No. Admn I/A-IV/ BPL/97-98/712 dtd. 19-11-1997 while it should have been fixed at the stage of Rs.6900/- (as drawn earlier as JAO on deputation to DOT ) ignoring my previous services rendered in the same cadre on deputation to Telecom Department. However, no pay protection was afforded to me to save from the financial loss as has been done in the cases covered under orders dated. 30.03.2011 ibid.

It perhaps needs no mention here that JAO cadre was re-designated as AAO vide Govt. of India notification dated 25.06.2009. Further vide ADG (SEA) OM No. 25-1/2010/SEA-II dated 30.03.2011, it has been decided to extend the protection of last pay drawn to all those AAOs who were on deputation and working in IP&T AFS Gr.-B in DoT upto 01.09.2009. Had the same benefit been extended to me also, my pay from time to time would have been as under-

Whatever justification existed for the officers as on 01.09.2009 existed while issuing orders dated 30.03.2011 ibid, the same are equally might have been available in our cases too for the pay protection, on return from DoT deputationist.

Instead, the DoT (HQ) seems to have taken up for protection of last pay drawn in advertently only for those AAO's who were on deputation on a particular day i.e. 01-09-2009. It is worth mentioning here that all rules/instructions framed under Fundamental Rules and service Rules need to be made applicable to all the officials who were on deputation irrespective of date of their repatriation or otherwise. There should not have been any targeted date for this benefit. Prescribing any particular day for this purpose violates the provisions of articles 14 & 16 of the Constitution Of India, which ensures provisions of equal opportunities for all, and equal pay for the equal work .

It is evident that the provisions of the aforesaid OM dt 30-03-11 created a lot of disparity in respect of those deputationist who were repatriated prior to the stipulated date i.e. on 01-09-2009 and later on promoted as AAO in their parent Deptt. i.e. Department of Posts. The orders dated 30-03-2011 are against the principles of equality as enunciated in the constitution. These orders deprived me the benefit of protection of last pay drawn. It is needless to humbly point out that my services also have come under I P&T AFS Gr. 'B' cadre (ie. under the same Ministry in which others particularly DOT deputationist worked as on the said date of 01-09-2009 after amalgamation of IP&T AFS Group 'B' cadre of the Deptt. of Posts and Deptt. of Telecommunication) on the very day of 01-09-2009 itself.


Due to non protection of my pay at the time of promotion as JAO (now AAO) on 20-11-1997, it caused severe, permanent and perpetual financial loss which will ultimately effect my pensionary benefits too.

I therefore, request your honour to kindly consider my case for the protection of last pay drawn at the time of repatriation from DoT on completion of deputation and provide the same pay of Rs. 6900 from date of promotion as JAO ie, w.e.f. 20-11-1997 in the Postal Deptt. followed by regular promotion on 01-01-08 under FR-22 on the similar lines as ordered by DOT H.qtrs. OM dated 30-03-11, so that I may not suffer financially on the fagend of my service career. It is needless to say that I am now to retire on superannuation in next year 2017 and if this anomaly is allowed to persist I will be suffering from a huge financial loss on account of retiral benefits as well as the admissible pension/family pension etc.

I therefore humbly once again request your kind honour kindly to provide me immediate redressal as prayed in above paras so that I may be saved from perpetual pecuniary loss. I shall be highly obliged for this act of kindness.
