Cadre Review of IP&TAFS -Distribution of sanctioned posts(SAG & above) regarding.

The first Cadre Review of IP&TAFS was approved by the Cabinet vide its decision dated 27.10.2016 and the same was notified vide Gazette Notification No.03-09/2015-SEA-I dated 10-11-2016

- 2. The post of Controller General of Communication Accounts (CGCA) at the Apex Level has been created and the same has been notified vide O.M. No. 3-9/2015-SEA-I dated 10.11.2016. The Office of CGCA would be an attached Office of the Department of Telecommunications (DOT) and will be located in Delhi.
- 3. The CGCA shall report to the Member (Finance), Telecom Commission.
- 4. The CGCA shall monitor the functions delegated by DoT Hqs. to the field offices (viz. Pr.CsCA/CsCA) under the overall supervision and control of Member (F), Telecom Commission. The delegation of administrative and financial powers to O/o CGCA shall follow shortly.
- The organizational structure and location of the field units can only be modified by DoT Hqs.
- 6. Pr. CsCA/CsCA shall continue to discharge such of Member(F)'s functions as have been delegated to them by orders of DoT Hqs,
- 7. The CGCA shall monitor the work of field Units (Pr. CCA/CCA) for the functions assigned to them by Department of Telecommunications (DOT). The CGCA shall also be entrusted with the function of cadre management of Group 'C' officials posted in the aforesaid field units. While the heads of field units shall continue to be the appointing authority of Group 'C' officials within their jurisdiction, the CGCA will be responsible for coordination, recruitment, recruitment rules etc. for the Group 'C' cadre. CGCA will also carry out internal audit of Pr. CCA/CCA offices and other DoT units such as the TERM Cells etc. Member(F) can order Special Internal Audit of any DoT unit including Office of CGCA.

- 8. The cadre management of the Gr. 'A' of IP&T AFS would continue to be with Member(Finance), Telecom Commission. Cadre management of Gr. 'B" of IP&T AFS would continue with Postal Accounts wing of Department of Posts.
- 9. One additional HAG+ post sanctioned in the cadre review (notified vide order No. 14-5/2016-SEA-I dated 27-04-2017) will be operated as Additional CGCA, who will assist CGCA in his day-to-day functioning.
