


The undersigned is directed to refer to letter No.20-100/2007/Spectrum/AS-I/1 dated 18.10.2007 granting In-Principle-Approval to M/s. Reliance Communications Limited to use GSM technology also in addition to the CDMA technology being used under the existing UAS Licence(s) for West Bengal, Andhra Pradesh, Bihar, Gujarat, Haryana, Himachal Pradesh, Jammu & Kashmir, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Orissa, Punjab, Rajasthan, Tamilnadu (including Chennai), Uttar Pradesh (West), Uttar Pradesh (East), Delhi, Mumbai and Kolkata service areas and to convey, on behalf of President of India, that the aforementioned In-Principle-Approval in respect of six service areas i.e. Bihar, Himachal Pradesh, Madhya Pradesh, Orissa, West Bengal and Kolkata service areas where its subsidiary company M/s. Reliance Telecom Ltd. is already operating GSM services under its existing UAS/ CMTS licences, is hereby withdrawn and the company is to be refunded the entry fee of Rs.112.5601 crores deposited by the company on 19.10.2007 for these six service areas in compliance of aforementioned In-Principle-Approval letter dated 18.10.2007.

2. Accordingly, Sanction of the competent authority is hereby conveyed to the payment of Rs.112.5601 crores(Rupees one hundred twelve crores fifty six lakhs and one thousand only) to M/s. Reliance Communications Limited, Vijay Building, 17, Barakhamba Road, Connaught Place, New Delhi-110001 on account of withdrawal of In-Principle-Approval granted to the company for usage of dual technology in six service areas as per detailed below:


