- 3. As per Order of Hon'ble High Court of Delhi, M/s Unitech Wireless (West) Pvt Ltd and M/s Unitech Wireless (South) Pvt. Ltd. have merged into M/s Unitech Wireless (Tamilnadu) Pvt Ltd, however, the request of the said companies in this regard for merger of the companies is yet to be taken on record by DoT.
