 - J. The up gradation granted under the order is purely non-functional up gradation, personal to the officer and it does not bestow any right to the officer to claim promotion or deputation benefits based on non-functional up-gradation in such a manner.
 - fl. Pay fixation on grant of functional up-gradation under the order has to be done as per the provisions of CCS (RP) Rules, 2008. At the time of regular promotion to this grade, the pay need not be fixed again for the officer who has been granted up gradation under these orders.
