2. Shri Jeetendra Kumar Meena failed to report for training on the stipulated date i.e., 16.07.2012. As per DoP&T's OM No. 35016/2/93-Estt.(D) dated 09.08.1995 an offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment. Accordingly, the offer of appointment issued to Shri Jeetendra Kumar Meena is hereby cancelled and he shall have no claim for appointment to the grade of JTS of ITS Group 'A' on the basis of results of ESE-2010.
