
AMENDMENT 1 OF 2014

Subject: Amendment to the Mobile Number Portability License agreement regarding 'Full Mobile Number Portability'.

In exercise of the power vested in the Licensor under condition 15.1 of Mobile Number Portability (MNP) Licence Agreements, inter-alia, reserving the right to modify at any time the terms and conditions of the LICENCE, in public interest, security of the nation or proper conduct of the SERVICE, the Licensor hereby amends, with immediate effect, the following clause(s) of the said Licences, namely:-

Cond . No.	Existing Condition	Amended Condition
12.5	The MCH and NPDB established by the licensee shall be used by all telecommunication service providers (both existing & new) (i.e. Basic, CMTS, UAS, NLD and ILD Licensee(s)) of the licensed MNP zone for the purpose of supporting porting of mobile numbers between mobile operators. As part of this activity, the Applicable System of Licensee shall contain the updated porting information which will be used by the telecommunication service providers for the purpose of routing calls to the ported end-users.	The MCH and NPDB established by the licensee shall be used by all telecommunication service providers (both existing & new) (i.e. Basic, CMTS, UAS, UL(AS), UL , NLD and ILD Licensee(s)) for the purpose of supporting porting of mobile numbers between mobile operators. As part of this activity, the Applicable System of Licensee shall contain the updated porting information which will be used by the telecommunication service providers for the purpose of routing calls to the ported end-users.

18.1	MNP is to be implemented in each intra Licensed Service Area (LSA). Initially MNP is to be implemented in all Metro and Category 'A' service areas within 6 month of award of the Licence. Later on, the operation of MNP will be expanded in the rest of the respective zones in time bound manner in phases. The total MNP implementation in each zone in the country shall be completed within 1 year of award of the Licence in respective zones.	MNP is to be implemented in inter and intra Licensed Service Area (LSA). The full Mobile Number Portability is to be implemented within a 6 months period in the Country from the date of this amendment to the Licenses.
30.7 (A) {new condi tion)		Recipient Operator shall forward the porting request for intra as well as inter Licensed Service Area portability to the Mobile Number Portability Licensee of the zone to which number range holder of the number (subscriber number under porting) belongs. Number range holder of the number means the Access Service provider to whom the numbering range has been allocated by Department of Telecommunications.
