The selection of the trainees will be made based upon the following criteria and the documents submitted on time to the APT Secretariat as stated below. Please read the "General Information on APT Training Course" carefully before nominating applicants. The APT Secretariat reserves the right to decline any application that does not meet the requirements.

The selection process of qualified nomination will be initiated as per the "HRD Guidelines for APT Fellowships under HRD Programme (2013)". Applicants are encouraged to register early as places in the training courses are limited. Priority will be given to the members who have not received the fellowships for our previous training courses. The acceptance process would also be made until reaching the maximum capacity of trainees as well as the budgetary limit for this training course.

Selection Criteria:

An applicant should:

- 1) be a university graduate or equivalent with working experience of more than 3 years in the field of telecommunications;
- 2) be currently engaged in planning or operation of broadband network and its access networks;
- 3) be a technical official in the administration or the regulator of telecommunications or be an engineer in the telecommunication operators;
- 4) be under 45 years of age;
- 5) not be serving in the military and,
- 6) meet the requirements set under "Guidelines for APT Fellowships under HRD Programme (2013)".

Fellowship (full/partial):

APT is pleased to offer your administration one full fellowship or two partial (half) fellowships to the training course. Your organization can select one full fellowship or two partial (half) fellowships when you nominate trainees for the training course. In the case of two partial fellowships, the first partial fellowship will cover the airfare only and the second fellowship will cover hotel accommodation and pocket allowance. The above selection criteria will equally apply to both the full fellowship and the partial fellowship.
