Subject:- Life verification process in respect of Combined Service Optees of MTNL, pensioners.

This is with reference to Pr. CCA Delhi letter N0 PDA/CCA/Misc/2015 dated 13-10-2015 and letter No.1-3/CCA-PDA/Jeevan Pramaan/2015-16 dated 20-08-2015 requesting to stagger the dates for acceptance of annual life certificate in respect of MTNL pensioners to be collected in the month of November every year.

- 2. In this regard reference is invited to para 6.1, para 6.2, note under para 6.2 and Annexure V of the "Guidelines issued to the CsCA for performing functions as Pension Disbursing Authority(PDA)" issued vide letter No.26-10/TA-I/2014/4635 to4637 dated 10-12-2014 and this office letter No.28-10-TA-I/2014 dated 25-02-2015 enclosing Ministry of Finance OM No.PAO/Tech/Amdt-Sch.Book/2014-15/720 dated 14-11-2014.
- 3. Annexure-V of instructions dated 10-12-2014 prescribe the authorities authorized to give life certificate to the pensioner and it has been clarified vide letter dated 25-02-2015 and note under para 6.2 that the digital life certificate in respect of pensioner based on Aadhaar Biometric Authentication may be accepted as a valid life certificate and pensioners may not be insisted to appear in person every year. The Pr. CCA Delhi and Mumbai have already confirmed successful uploading of pensioners data in the Jeevan Pramaan Portal.
- 4. The authorities prescribed vide Annexure V of Guidelines dated 10-12-2014 are further amended in accordance with the provisions of Rule 343 of Central Treasury Rules (CTR) and the revised Annexure V is enclosed herewith which supersedes the earlier Annexure V.
- 5. In the light of the above, the Pr. CCA Delhi & Mumbai as PDA may not insist upon pensioners to present themselves physically if the life certificate is submitted duly signed by the authority as per the revised Annexure V mentioned in para 4 above as well as Aadhaar based authentication of life certificate.

- 6. The Pr. CCA Delhi and Mumbai may also give adequate publicity for submission of Aadhaar based authentication of life certificate and provide the details of steps to be taken up by the pensioners in this regard on their website. Pr. CCA offices Delhi and Mumbai may accept life certificate of all the combined service optee pensioners of MTNL.
- 7. MTNL, may collect life certificate from its pensioners duly signed by the prescribed authority and forward to CCA Delhi & Mumbai on daily basis to facilitate the pensioners. MTNL is also requested to encourage the pensioners to submit Aadhaar based authentication of life certificate and provide facilities to its pensioners for submitting the same.
- 8. The format of life certificate has been revised by including the following along with the provision of acknowledgement to pensioners (Annexure-A)
  - 1. Present address of the pensioner/family pensioner
  - 2. Telephone/Mobile number
  - 3. E-mail Address
  - 4. Aadhaar number

  - a Pensioned Officer who, before retirement, exercised the powers of a Magistrate;

a Block Development Officer, Munsif, Tehsildar or Naib Tehsildar; ix)

- a Head of Village Panchayat, Gram Panchayat, Gaon Panchayat or on Executive Committee of a village:
- Members of Parliament, of State Legislatures or of legislatures' of Union Territory Government/Administrations.
