1. COMPANY PROFILE

MTNL is a schedule – 'A'/ Navaratna CPSE in Telecommunications and Information Technology Services sector under the administrative control of Department of Telecommunications, Ministry of Communication and Information Technology.

The authorized and paid up capital of the Company were Rs. 800 crores and Rs. 630 crores respectively as on March 31, 2014.

Its Registered and Corporate offices are at New Delhi.

The shareholding of the Government of India in the Company is 56.25%.

2. JOB DESCRIPTION AND RESPONSIBILITIES:

Director(Technical) is a member of Board of Directors and reports to Chairman and Managing Director.
