3.	Shri Awadhesh Kumar Singh, ADG (EW), Staff No. 96564	-----	-----	Sh. Awadhesh Kumar Singh, ADG (EW), DoT (Hq.), New Delhi will look after the additional charge of ADG (E), DoT (Hq.) without any extra remuneration.

2. Deployment of Shri Naresh Kumar, EE (E), in MTNL shall be governed by following Terms & Conditions:

- (i) The officer will not be paid any deputation allowance.
- (ii) During the period of his deployment in MTNL, he will continue to be Government servant and will draw pay & allowances as are admissible to the Government officers of the equivalent grade.
- (iii) He will also be eligible to apply for deputation/foreign service deputation in organizations other than MTNL and will also participate in the central staffing scheme [currently P&T BWS is not under Central Staffing Scheme].
- (iv) The post of MTNL against which the officer would be deployed would not be counted towards cadre strength for the purpose of promotion. Besides the officer shall also be entitled to be considered for promotion against post falling vacant in DoT as a result of officers being deployed to fill vacancies in BSNL and MTNL that these organizations are unable to fill for want of internal personnel eligible for such promotion.

- (v) Leave salary & pension contribution shall be paid by MTNL to the Central Government i.e DoT as per extant rules.
- (vi) The period of deployment of the officer to MTNL shall not be counted towards any ceiling on period of tenure deputation to other departments /organizations, including posting under Central staffing Scheme [Currently P&T BW is not under Central Staffing Scheme].
- (vii) For the purposes of the proposed deployment, MTNL shall be exempted from the rules of immediate absorption.
- (viii) The inter-unit transfer and posting of officers between DoT and BSNL/MTNL shall continue to be made by DoT. However, CMD, BSNL/MTNL shall exercise full control over transfer/posting of officers while they are posted in these organizations.
3. The officers concerned may be relieved and directed to report to their respective place of posting immediately. Necessary charge report shall be furnished to all concerned.
