Subject: Transfer of ILD & NLD Licenses of M/s Spice Communications Limited to M/s Idea Cellular Limited.

In pursuance of Clause No. 11 of the International Long Distance (ILD) and National Long Distance (NLD) Licence agreement and in consideration of requests of M/s Idea Cellular Limited dated 28.4.2010, 28.02.2011, 03.02.2014 & 05.08.2014, the undersigned is directed to convey the approval of the Competent Authority for transfer of International Long Distance (ILD) Licence [No. 10-08/06-BS-I (ILD-13) dated 8.8.2007] and National Long Distance (NLD) Licence [No. 10-07/06-BS-I (NLD-18) dated 8.8.2007] of M/s Spice Communications Limited to M/s Idea Cellular Limited and stand amended to the following effect:-

- (i) The text "Spice Communications Limited" wherever appearing in the above Licence Agreements is substituted with "Idea Cellular Limited".
2. This amendment shall be effective from the date of issue.
3. All the obligations/liabilities/dues of all kind in respect of the Licence Agreements including roll-out obligations shall stand transferred to the new Company M/s Idea Cellular Limited.
4. The Performance and Financial Bank Guarantees submitted to the Department may accordingly be amended within two weeks from the date of issue of this letter to incorporate the new name.

Subhand

5. This amendment shall be part and parcel of the Licence Agreement. The other terms and conditions of the Licence agreement shall remain unchanged.

6. The above mentioned transfer of ILD & NLD Licenses of M/s Spice Communications Limited to M/s Idea Cellular Limited is subject to submission, within 7 days, of an undertaking from M/s Idea Cellular Limited in the proforma attached.

7. Subsequent to taking of record of transfer of ILD and NLD License of M/s Spice Communications Limited to M/s Idea Cellular Limited, M/s Idea Cellular Limited would be holding two (2) NLD Licenses. M/s Idea Cellular Limited will have to surrender one of the NLD Licenses with immediate effect.
