

## ORDER

SUBJECT: Deputation of Shri Arokianathane Robert Jerard Ravi as I&CT expert to the Government of Uganda for a period of one year under ITEC programme.

Sanction of the President is hereby accorded to the deputation of Shri Arokianathane Robert Jerard Ravi as I&CT expert to the Government of Uganda for a period of one year under ITEC programme in terms of Ministry's letter No. B.2311/14/08 dated 9.6.2010.

2. Pay : Shri Arokianathane Robert Jerard Ravi will draw Band Pay and Grade Pay per month as mentioned below:-

Band Pay Rs. 56,850.00 (with usual increment when becomes due)

Grade Pay Rs. 10,000.00

3. He will draw Compensatory Allowance of US\$ 3,007/- p.m. for a notional rank equivalence with Minister as fixed by the Ministry. It may be noted that the rates of Compensatory Allowance may be increased/decreased in accordance with Ministry's extant policy on fixation/revision. The Electricity, Water & Fuel (EWF) charges of US \$ 215/83 are included in the above-mentioned Compensatory Allowance. In case the bills towards consumption of electricity, water and fuel are paid by the host Government, the recoveries on account of Electricity, Water and Fuel may please be made from the Expert as follows:-

Electricity @ 70 % of EWF per month Water @ 10 % of EWF per month Fuel @ 20 % of EWF per month

The Expert shall have no representational obligation and he, irrespective of rank, would not be in receipt of any other allowance, of any kind. The Compensatory Allowance will be reduced by 50% if the recipient Government provides full board and lodging free of charge to the official. If an allowance is given by the recipient Government in lieu of free board and if it is less than the Compensatory Allowance admissible in the country, the difference between the two may be sanctioned by the Government of India.

- 4. The rank of the officer shall not be upgraded during the course of his deputation abroad due to any reason such as promotion in his parent cadre, revision of pay scale from a retrospective or prospective date, earning of annual increments MACP etc.
- In case the expert becomes due for promotion in his regular line in his parent department/office, he
  will NOT be entitled to proforma promotion and/or financial benefits accruing therefore during the period of
  his deputation.
- Additional Compensatory Allowance: He will also be paid additional Compensatory Allowance
  in lieu of income tax as long as it is admissible.
- 7. He will be provided with furnished accommodation, medical facilities and local transport for official purposes by the receiving Government as admissible under ITEC rules.

- 8. He will be entitled to carry 560 kgs. of personal effects by air as unaccompanied baggage inclusive of free allowance per ticket given by the air company which can be carried as accompanied baggage and the baggage admissible under the mandatory orders <u>OR</u> the expert have the option to carry personal effects! v surface route up to a maximum of 1400 kgs. inclusive of free allowance given by the air company and the baggage admissible under mandatory orders inclusive of weight of lift vans packing material etc. The term personal effect will not include motor vehicles.
- 9. During the deputation period, he will be governed by the provisions of IFS (Conduct and Discipline) Rules 1961 as amended from time to time and will be under the administrative control of High Commission of India, Kampala.
- 10. He will be required to submit regular six monthly report on his work to DPA-II Division, Ministry of External Affairs in the prescribed format. Also, upon completion of his deputation, he shall submit a detailed report to DPA-II Division of Ministry of External Affairs through the Indian Mission in Uganda.
- 11. The entire expenditure incurred will be debitable under Grant No. 28 of Ministry of External Affairs, Major Head:-

Technical and Economic Cooperation with other countries;

00.101 - Cooperation with other countries
20 - "Aid to African Countries"
20.00.32 - Contribution (Non-Plan)
