Subject: Implementation of eOffice-Lite (SPARROW) in DoT – Learning & Testing of Portal and Workshop for Role Admin/Nodal Officers (PAR Custodian & EMD Manager).

As you are aware that eOffice-Lite (SPARROW) is being implemented (<https://sparrow-dot.eoffice.gov.in/>) for DoT Officers (ITS, IP&T AFS, IP&T BWS and IRRS Cadres) for filling up of eAPAR from the year 2016-17 onwards.

2. The eOffice-Lite (SPARROW) portal of DoT is being made functional for awareness, learning and testing during 07.04.2017 to 12.04.2017. The instructions and manuals issued by IT division on the subject are available at <http://dot.gov.in/circular-and-notifications/2323>. Subsequently, the portal would be made live after necessary modifications, if any and after deleting all the eAPARs generated temporarily for the learning and testing purposes.
