OFFICE MEMORANDUM

Subject: Observance of "Vigilance Awareness Week - 2020" in Department of Telecommunications from 27th October to 2nd November, 2020

The undersigned is directed to refer to Central Vigilance Commission's Circular No. 09/09/2020 dated 08.09.2020 on the above mentioned subject, and to convey that Vigilance Awareness Week - 2020 will be observed in Department of Telecommunications w.e.f. 27.10.2020 to 02.11.2020 with the theme "सतर्क भारत, समृद्ध भारत - Satark Bharat, Samriddh Bharat (Vigilant India, Prosperous India)".

- 2) With the objective of spreading vigilance awareness among the employees, the following events will be conducted in DoT (HQ) during the week observing all precautions and Social Distancing norms in view of current Covid-19 pandemic situation:-

3. The details of the events are as under:

a) The Vigilance Awareness Week (VAW) will commence with the “**Integrity Pledge**”, to be administered by Secretary (Telecom) on 27.10.2020 at 11:00 hrs at Conference Hall, 2nd Floor, Sanchar Bhawan through live web-cast/ Web-link. Few Senior Officers of the Department will take pledge in the Conference Room and all other officers/ officials of Sanchar Bhawan may join it from their respective offices / rooms through a web-link in view of Covid -19 pandemic. Besides this, a TV Screen will also be installed near IRCTC Canteen in Ground floor lobby of Sanchar Bhawan for web-casting of the Pledge for the participation of remaining officers/ officials of DoT in limited number, who wish to join there, following due precautions and social distancing norms.

b) All Officers and Staff are also requested to take e-Integrity Pledge, available on the CVC/s website <http://www.cvc.gov.in> in preferably during this week (VAW).

c) **SIGNATURE CAMPAIGN:** - All employees are requested to put their signature on the campaign board, displayed on Ground Floor throughout the VAW, to support the resolution:- “सतर्क भारत, समृद्ध भारत - **Satark Bharat, Samriddh Bharat.**

d) **ESSAY WRITING COMPETITION:** - Competition will be held on 27.10.2020 at 02.30 p.m. in Conference Hall, 13th floor, Sanchar Bhawan. Participants will be required to write an essay in English or Hindi of maximum 1200 words on a topic with time limit of an hour. Topic of the essay will be notified in due course of time.

Cash prizes and Certificates will be awarded to the participants securing 1st, 2nd and 3rd positions and two consolation prizes will also be awarded.

e) **QUIZ CONTEST** (relating to questions on Vigilance rules, guidelines, procedures of CCS (CCA) Conduct Rules, 1965):- The contest will be organized on 28.10.2020 at 10.30 am, in Conference Hall, 13th floor, Sanchar Bhawan. Entry for the participants will be allowed on first come first serve basis, in limited number, as per the capacity of the hall following strict social distancing norms in view of Covid-19 pandemic. Cash prize will be awarded for each correct answer.

Note: Participation of officer/ staff of Vigilance Wing if prohibited for Quiz Contest.

f) **DEBATE COMPETITION:** - The Competition will be held on 28.10.2020 at 2.30 pm, in Conference Hall 13th floor, Sanchar Bhawan. Participants are required to speak either in favour or against the given topic. Further, each participant is expected to conclude within prescribed time limit of approximately 6 Minutes. Breach of time may attract penalty points while evaluating the competition. Topic of the debate will be announced in due course.

The participants can speak either in Hindi or English. Cash prizes and Certificates will be awarded to the participants securing 1st, 2nd and 3rd positions and two consolation prizes will also be awarded.

g) **POSTER MAKING COMPETITION:-** All employees are requested to participate in the event by submitting a full chart paper size poster relating to Prevention of corruption, including Vigilance awareness / Anti-corruption/ Preventive vigilance etc. or on the theme of this year's Vigilance Awareness Week. Such posters should be handmade and can be prepared by the employees and their immediate family members. The posters can be either in Hindi or English and must be submitted latest by 05.00 p.m. of 28.10.2020 to Mrs Prasan Kujur, SO, Cabin No. 10, Room No. 910 , Sanchar Bhawan (email: prasannk.ekka@nic.in). Cash prizes and Certificates will be awarded to the participants securing 1st, 2nd and 3rd positions and two consolation prizes will also be awarded. Awarded posters will be displayed on the display boards for public viewing.

g) **SLOGAN WRITING COMPETITION:-** All employees and their immediate family members are requested to take part in this event by writing a slogan either in Hindi or English on the subject relating to Prevention of corruption including Vigilance awareness/ Anti-corruption/ Preventive Vigilance etc. or on the theme of this year's Vigilance Awareness Week and sending the same to Smt.
