ORDER

Subject: Regular promotion to the Senior Administrative Grade of ITS Group 'A'.


In continuance of this office order of even no. dated 30.09.2011, Shri Gajendra Kumar Lodha (Staff No. 8084) is hereby promoted to Senior Administrative Grade of ITS Group-A on regular basis, notionally with effect from 25.02.2013 i.e. the date following the date on which currency of penalty imposed on the officer gets over and actually with effect from the date of assumption of charge in the higher grade. On promotion to SAG of ITS Group-A, Shri G K Lodha will remain posted in BSNL.

2. On promotion, seniority of Shri G K Lodha in SAG of ITS Group-A is fixed above Shri S P Singh (Staff No. 8502) and below Shri Adhir Kumar Singhal (Staff No. 8625) as per recommendations of DPC held on 19.09.2011. However, Shri S P Singh (Staff No. 8502) has not been promoted so far to SAG of ITS Group-A. Accordingly, seniority of Shri Lodha is presently fixed above Shri B V Balasubramanaya (Staff No. 8525). His seniority will be fixed above Shri S P Singh, when Shri Singh gets promotion in SAG of ITS Group-A against the vacancy year 2011-12 as per recommendations of the DPC held on 19.09.2011.

3. The above promotion order is being issued after obtaining the vigilance clearance from the Vigilance Branch, DoT HQ. However, in case it comes to the notice of the Controlling Authority that disciplinary case is pending or any punishment of stoppage of increment etc is in operation/currency against the officer, the officer should not be promoted without obtaining the specific approval of this department. Information in this regard may be brought to the notice of this department forthwith.


4. The other terms and conditions as mentioned in the order of even no. dated 30.09.2011 will remain the same.
