OFFICE MEMORANDUM

Subject: Filling up the post of Director(Tele) in the Cabinet Secretariat(R&AW).

The undersigned is directed to state that it is proposed to fill up two posts of Director(Tele) in the Telecommunication Cadre of Cabinet Secretariat (R&AW) on deputation basis.

2. The eligibility criterion for appointment on deputation basis for the post of Director (Tele) in the Cabinet Secretariat (R&AW) are as under :-

(i)	Post	: Director (Tele)
(ii)	Pay Scale	: Pay Band - 4 of Rs.37,400 - 67,000/- with Grade Pay Rs.8700/-
(iii)	Qualification	: M.Sc (Physics) with Wireless Communications or Electronics or Radio Physics or Engineering as special subject. OR Degree in Electronics / Telecommunication Engineering.
(iv)	Eligibility	: Persons holding analogous posts on regular basis in Central Government Civilian Organization or officers in the Pay Band-3 of Rs.15,600-39,100/- with Grade Pay of Rs.7600, who have rendered not less than 07 years of regular service in the grade. The Armed Forces personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualification shall also be considered. Such persons would be given deputation terms up to the date on which they are due for release from the Armed Forces. Thereafter, they may be continued on re-employment. Volunteer officers from Armed Forces should be holding grade equivalent to Director.
(v)	Experience	: 10 years experience in research, installation, operation and maintenance of telecom systems, preferably in radio engineering consisting of HF, VHF, UHF, Microwave and Satellite fields.
(vi)	Age limit	: The maximum age limit for appointment on deputation shall be 56 years.

2. The incumbent in addition to deputation benefits would be entitled to Security Allowance as admissible.

3. It is, therefore, requested to nominate eligible and willing officers for appointment to the post of Director (Tele) on deputation basis and also forward their bio-data and ACR dossiers for last 5 years along with Vigilance and Cadre Clearance Certificate to this Secretariat latest by 30.10.2009.
