

(b) While forwarding the application, circle office may intimate whether any penalty (Major/Minor) has been imposed on the officer during the last five years.



Subject: Panel of Names for filling up the posts in UIDAI at its Regional Offices

Dear Shri Behura,

As you are aware, the Government of India has set up Unique Identification Authority of India (UIDAI) in January 2009 as an Attached Office of the Planning Commission. Subsequently, Shri Nandan Nilekani has been appointed as the Chairman of the Authority and he has assumed charge on July 23, 2009. The mandate of the Authority is to issue Unique ID numbers to all the residents of India.

2. The Authority is in the process of recruiting officers at various levels. It has its headquarters in Delhi and eight Regional Offices located at Bangalore, Chandigarh, Delhi, Guwahati, Hyderabad, Lucknow, Mumbai and Ranchi. Besides, its Technology Centre will be located in Bangalore. Each Regional Office has four posts of Assistant Director General (ADGs) at the level of Director to the Government of India. About half of these posts are to be filled up from the Officers from All India Services / Central Services on deputation basis under the non-Central Staffing Scheme.

3. For filling these non-central staffing scheme posts, you are requested to forward a panel of the names of willing Officers who - (a) are holding analogous post in the Grade pay of Rs. 8,700/- or (b) have rendered a minimum three years of continuous service in the immediate lower grade for consideration of the Authority.

4. While forwarding the panel of names of the suitable Officers who are willing to join the Authority, you are requested to kindly ensure that their services are available to the Authority uninterruptedly for a period of five years.

5. As we intend to complete the selection process by the first week of November, 2009, I shall be grateful if the panels of names of the suitable Officers for these posts are forwarded to the undersigned by 26th October 2009. I shall be grateful if utmost priority is accorded to the request.
