**Subject: Information sought under RTI Acr,2005**

The Union Cabinet had approved the first Cadre Review of the IP&TAFS Group A on 27.10.2016(which was subsequently notified by DOT vide OM No 3-08/2015 SEA 1 dated 10.11.2016).Implementation of above Cadre Review was to be carried out within 4 months.

Since above approval more than one year has elapsed.

Vide above approval,one apex level encadred post was created and one HAG+ post was created.

Shri Prahalad Singh joined as CGCA in the apex encadred post on 27.04.2017.

Since then,more than six months have elapsed

Smt.Sumita Purkayastha joined as ACGCA in the above created HAG+ post on 08.05.2017

Since then, nearly six months have elapsed.

Not a single officer,or official or staff either in Group A or Group B or Group C or Group D has been posted/allotted to the O/O CGCA or to ACGCA.Not a single official file or functioning has been given to either of the two officers.No powers(whether Administrative or Financial) have been given to either of the two above officers till date.

5. The functions/functionalties as approved by the Union Cabinet which justified creation of above posts.
6. The functions and functionalities given to CGCA vide DOT Notification dated 13<sup>th</sup> June.
