

Dear Shri Behura,

As you are aware, the Government of India has set up Unique Identification Authority of India in January 2009 as an Attached Office of the Planning Commission. Subsequently, Shri Nandan Nilekani has been appointed as the Chairman of the Authority and he has assumed charge on July 23, 2009. The mandate of the Authority is to issue Unique ID numbers to all the residents of India.

The Authority is in the process of recruiting officers at various levels. It has six Posts of Deputy Director General (DDGs) at the level of Joint Secretary to Govt. of India and 18 posts of Assistant Director General (ADGs) at the level of Director to the Government of India at its Headquarters in Delhi. About half of the posts in both these categories are to be filled up from the Officers from All India Services /Central Services on deputation basis under the non- Central Staffing Scheme.

For filing these non-central staffing scheme posts, you are requested to forward a panel of the names of willing Officers holding either analogous post in the Grade pay of Rs. 10,000/- and Rs. 8,900/- or rendered a minimum three years of continues service in the immediate lower grade for consideration of the Authority. While forwarding the panel of names of the suitable Officers who are willing to join the Authority immediately, you are requested to kindly ensure that their services are available to the Authority uninterruptedly for a period of five years.

As we intend to complete the selection process by the first week of October, 2009, I shall be grateful if the panel of names of the suitable Officers for the post of Deputy Director General in the Grade Pay of Rs. 10,000/- and Assistant Director General in the Grade Pay of Rs. 8,900/- along with their ACRs for the last five years are forwarded to the undersigned by 25th September, 2009.

Given the designated time lines for starting of the selection process, I shall be grateful if utmost priority is accorded to the request.
