ORDER

Re-fixation of seniority of Shri Dinesh Kumar Gupta (Staff No. 21120), an officer of ITS Group-A, consequent upon passing of Professional Examination.

Shri Dinesh Kumar Gupta (Staff No. 21120) an officer of ITS Group-A was not promoted to Senior Time Scale of ITS Group-A alongwith his batchmates since he had not qualified professional Examination alongwith them. The officer later qualified the same in May 2006 alongwith 2000 batch and was promoted to STS of ITS Group-A against the vacancy year 2006-07 vide DoT order no. 11-02/2006-STG I dated 05.06.2006. The officer was later promoted to JAG of ITS Group-A alongwith 2000 batch vide DoT order no. 314-04/2011-STG III dated 21.10.2011. However, seniority of the officer was fixed just below Shri Ajay M Mhetre (Staff No. 20917), who is placed below the last officer of 2000 batch i.e. Shri Vinay Kumar Kokade (Staff No. 21237.

- 2. The officer represented for fixation of his seniority above Shri Atul wakhle (Staff No. 21121) on account of his passing professional examination. Later, he filed an OA no 206/2012 before Hon'ble CAT, Jabalpur Bench for the same. Hon'ble Tribunal vide its Order dated 01.03.2012 has directed to consider the representation of the officer and decide the same by the Competent Authority by a speaking order.
- Accordingly, the case has been examined in this department and it has decided that request of the officer for fixation of his seniority above Shri Atul Wakhle can not be acceded to as the officer did not qualify professional examination with his batchmates. At present, the seniority of the officer is above Md. Shahkar Bari (Staff No. 11115) and below Shri Ajay Mhetre (Staff No. 20917) i.e. below all the officers of 2000 batch of ITS Group-A. Now, it has been decided that seniority of the officer is to be fixed above the very first officer of 2000 batch, i.e. just below the very last officer of 1999 batch of ITS Group-A. As such, seniority of Shri Dinesh Kumar Gupta has been fixed above Shri A Srinivasa Rao (Staff No. 21174), who is the first officer of 2000 batch of ITS Group-A and below Shri Dwarka Karol (Staff No. 21173), who is the last officer of 1999 batch of ITS Group-A.
