## Subject: Auction of 3G Spectrum: Update on Payment Methodology

With reference to Section 4.5 (Payment Methodology) of the Notice Inviting Applications for the Auction of 3G and BWA Spectrum, all Successful Bidders in the 3G Auction are hereby informed that they can make payment of the required amount through either one of the following two methods:

- Through Demand Draft in favour of "Pay and Accounts Officer (HQ), DoT, New Delhi" drawn on a Scheduled Commercial Bank payable at Delhi. The Demand Draft/s must be accompanied by a covering letter listing the service areas and corresponding amounts in respect of which the payment is being made and handed over to the Pay and Accounts Officer (HQ), DoT, Room No. 801, Sanchar Bhavan, Ashoka Road, New Delhi during working hours from Monday to Friday; OR
- 2. Through Real Time Gross Settlement (RTGS)/ Core Banking facility as per the following instructions:
