Various issues regarding applicability of Rule 37, retirement/terminal benefits etc. have been raised with regard to ongoing recruitment process initiated by BSNL/MTNL for Group 'A' ITS officers. These issues have been received in DOT/BSNL/MTNL as well as during the video conferencing held on 14th and 15th February, 2012 with all the circles of BSNL by Chairman, Telecom Commission and Secretary (T), Member (Services), Member (Finance) and CMD, BSNL along with senior officers and examined in DOT in consultation with DDG (Establishment) and Finance Wing with due approval of Member (Services) and Member (Finance).
