APPELLATE ORDER ON APPEAL DATED 28.06.2017 FILED BY SH. A.K. SHARMA.

I, the Appellate Authority in the Department of Telecommunications have carefully gone through the appeal dated 28.06.2017 filed by Sh. Sh. A.K. Sharma:-

Facts of the case:-

1. Sh. A.K. Sharma sought the following information under RTI Act, 2005 vide his application dated 25.05.2017:-


“Copy of Final seniority list of officers in the Senior Administrative Grade (SAG) of the Indian P&T Accounts and Finance Service Gr. “A” as on 01.07.2003, circulated vide your office No. 33-11/2003-SEA-I dated 26.09.2003. Only page No. 1 and 2 covering Serial No. 01 to 47 may be provided”.

2. The appeal of the applicant is “the copy of the seniority list is not authenticated by any signature/stamp of the competent authority”
3. The CPIO has intimated that the information as sought for in the application has already been supplied to the applicant vide this office letter No.33-04/2017-SEA-I dated 15.06.2017.

Decision of the appeal

I, Saurabh Kumar Tiwari, the Appellate Authority in the Department of Telecommunications have carefully gone through the appeal dated 28.06.2017 filed by Sh. A.K. Sharma w.r.t. the supply of information CPIO vide his letter dated 15.06.2017 and have come to the conclusion that:-

1. The applicant has requested in his RTI application dated 25.05.2017 to supply only page No. 1 and 2 covering Serial No. 01 to 47 to him. The applicant did not demand for certified copy of the documents. Therefore the information as asked by the application has been supplied to him.
2. Accordingly appeal dated 28.06.2017 is disposed off.
