2. The vigilance clearance in respect of **Shri M.Q.Ansari** (Staff No. 05057) (indicated at **Sl. No.40**), **Shri R.K.Vyas** (Staff No.06258) [indicated at **Sl. No. 65**], **Srri Vakil Chand Gupta** (Staff No. 07236) (indicated at **Sl. No.90**) is withheld. Accordingly these officers shall be given only provisional pension. The DGRG and CVP in respect of these three officers shall be withheld till the conclusion of disciplinary proceedings / prosecution case as per CCS (Pension) Rules, 1972. The action taken in this regard may be brought to the notice of Sr. DDG(Vig.) and DDG(Estt.) of this office immediately.

3. It may be ensured that no disciplinary/vigilance case is pending or contemplated against any of the remaining 89 officers mentioned in Table under Para 1 above. If any such case comes to notice, only provisional pension shall be granted to the officer(s) and his DCRG and CVP shall be withheld till the conclusion of disciplinary proceedings as per CCS (Pensions) Rules, 1972. Such cases should be brought to the notice of Sr. DDG (Vigilance) and DDG (Estt.) of this office immediately.
