Kindly refer to this office letter no even dated 22.12.2016 (copy attached) intimating implementation of Non Tax Receipt portal (Bharatkosh) for accepting online receipts w e f 30 Dec 2016 from all stakeholders i.e., TSPs/ISPs/individuals.

A total of 9,965 transactions have already been successfully carried out through NTRP portal as on date amounting to Rs. 4,638 crores in DoT. A special drive was conducted to review the status of online receipts of the department and it has been noticed that even after a lapse of five months some stakeholders i.e., TSPs/ISPs/individuals are still submitting bank drafts to various Wings/Sections.

In line with the significant Digital India initiative of GOI and Cabinet decision of February 24, 2016 making it mandatory for all Government departments to ensure all receipts and payments through digital means, Accounts Wing of DoT had issued instructions regarding implementation of Non-Tax Receipt portal (BharatKosh) for accepting all types of receipts through online mode by 30 June 2017 from all stakeholders i.e, TSPs/ISPs/ individuals vide this office letter no. even dated 29.05.2017 (copy attached).

As on date, a total of 19,052 online transactions have already been successfully carried out in DoT through NTRP portal amounting to Rs. 6,700 crores within a span of 10 months and the NTRP portal is fully functional and established. However, it has been noticed that some Wings are still accepting bank drafts from the stakeholders i.e, TSPs/ISPs/individuals inspite of clear instructions in this regard.

Therefore, it is once again requested to encourage stakeholders/service providers to make payment only through online mode by using NTRP portal since all the "Purposes" have already been mapped form the backend in the NTRP portal by Accounts Wing to facilitate and achieve the mandate of 100% digital receipts as per Cabinet decision. Hence, all efforts may be made to ensure that all payments to DoT are made online through NTRP portal wef 03 Oct 2017.
