1.2 The Licensee shall declare the Indian & Foreign equity structure (both direct and in-direct) in the Licensee company and submit a compliance report regarding compliance of FDI norms and security conditions on 1st day of January of every year to the Licensor in Proforma as may be prescribed from time to time. This is to be certified by Company Secretary or Statutory Auditor, countersigned by duly authorized Director of the Licensee Company.

When there is a change in FDI in the Licensee's company, the Licensee shall also submit the FDI compliance report within 15 days.

2. This amendment shall be part and parcel of the "sui-generis" category License Agreement and all others Terms & Conditions shall remain unchanged.
