ADVERTISEMENT FOR THE POST OF MEMBER (SERVICES) IN THE TELECOM COMMISSION, MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY

One (1) Post of Member (Services) in the Telecom Commission under the Department of Telecommunications carrying pay and allowances equivalent to that of Secretary to the Government of India will fall vacant on 01.09.2016. Member (Services) is also the ex-officio Secretary to the Government of India. The tenure of the post is till the incumbent attains the age of 60 years. The appointment will be made by Deputation (including short term contract/absorption) in accordance with the Recruitment Rules, 2014.

2. Applications are invited from the serving officers of Central Government or State Governments or Governments Union Territories or Semi Government or Statutory Bodies or Public Sector Undertakings or Autonomous Bodies or Recognized Research Institutions who possess the following requisite qualification and experience as prescribed in the Recruitment Rules, 2014, as under:

- (A) (I) Holding analogous posts on regular basis in the parent cadre or Department; or
(II) Minimum two years of regular service in the HAG scale Rs. 67000-79000) or equivalent rendered after appointment thereto on regular basis; and

(B) Possessing the following educational qualifications and experience:

Essential Qualifications:

- (I) Degree in Engineering in Electrical or Electronics and Electrical Communications or Computer Science from a recognized institution or University or Associate Member of the Institution of Engineers [AMIE (Electrical)] or Graduate from Institute of Electronics and Telecommunications (IETE)*;
- (II) Working experience of twenty years in the field of Telecommunications Technology in Government or Industrial Enterprises including exposure to and knowledge of International Telecommunications Union and the Law of International Telecommunications Union.

* Degree in Electronics or Electronics and Communications or Electrical Communications or Telecommunications will be treated as equivalent.

Desirable:

- I. Masters Degree in Engineering in Electrical or Electronics and Electrical Communication or Computer Science from a recognized institution or University.
- II. Masters Degree in Management Studies, Masters Degree in Business Administration (MBA) from a recognized institution or University.

Note:

- I. Officers working in Central or State or Union Territory Governments shall only be eligible for absorption.



- II. Period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organizations or Department of the Central Government shall ordinarily not to exceed five years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding fifty six (56) years as on the closing date of receipt of applications.
- III. The normal eligibility conditions of maximum age of fifty six years on date of closing of receipt of application shall not be applicable in cases of absorption. The officers with minimum one year's residual service on the date of occurrence of vacancy shall be eligible for appointment by absorption.
- IV. For the purpose of appointment on deputation or absorption basis, the service rendered on regular basis by an officer prior to 1.1.2006 (the date from which the revised pay structure based on the 6th Central Pay Commission(CPC) recommendations has been extended) shall be deemed to be service rendered in the corresponding Grade Pay or Pay Scale extended based on the recommendation of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay or Pay Scale, and where this benefit will extend only for the post(s) for which that Grade Pay or Pay Scale is the normal replacement grade without any upgradation.

3. Applications in the prescribed format as given below may be submitted through respective Cadre Controlling Authorities so as to reach the undersigned within 60 days from the date of publication of this advertisement along-with vigilance clearance, Integrity certificate, statement showing major-minor penalty imposed during the last 10 years and complete ACR dossiers.

4. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
