Subject: Availing Cloud Services from MeitY empanelled Cloud Service Providers (CSPs)

As you may be aware, Ministry of Electronics & Information Technology (MeitY) launched MeghRaj (GI Cloud) initiative in 2013 to utilize and harness the benefits of Cloud Computing. The focus of this initiative is to accelerate delivery of e-services in the country while optimizing ICT spending of the Government.

2. MeitY, as part of the MeghRaj initiative, came out with the "Cloud First" policy under which a National Cloud by NIC is providing Cloud services to Government Ministries / Departments. MeitY has also empanelled Cloud Service Offerings of Cloud Service Providers (CSPs) in September 2016. Additional CSPs are also being empanelled by MeitY.

3. The Ministries/Departments and organizations can use the Cloud services of the MeitY empanelled CSPs, who are audit compliant, for their IT requirements. The status of audit compliance by CSPs can be seen at <http://meitv.gov.in/content/gi-cloud-meghraj>.
