

OFFICE MEMORANDUM

Subject: Extension of CGHS facilities to the Family Members of IAS Officers and other Central Government servants who are transferred to Jammu and Kashmir and North Eastern States during their stay in Delhi.

The undersigned is directed to refer to this Ministry's O.M. No. S-11011/6/90-CGHS (P) dated 19<sup>th</sup> Sept. 1990, O.M. No. 4-19/2002-C&P/CGHS/CGHS(P), dated 5<sup>th</sup> July 2005 and S-11011/2/2012-CGHS(P) dated 2<sup>nd</sup> July 2012 regarding extension of CGHS facilities to the family member of IAS officers and other Central Government Employees who stay back at the previous station of posting, on the employees being posted to J&K, North Eastern States/ UTs, Andaman & Nicobar and Lakshadweep Islands.

2. In case the family members stay back in CGHS covered area, there is a provision for CGHS facility for the family members on payment of CGHS subscription on yearly basis through the old office.

3. In order to alleviate the problems being faced by the IAS Officers and other Central Government Employees posted in J&K and North Eastern States in getting CGHS card on yearly basis, it has been decided that the CGHS facilities may be extended to the families of IAS officers of J&K and North-Eastern States on completion of Central Deputation and other Central Government Employees posted in J&K and NE states on advance payment of CGHS subscription for 1yr/2yrs/3yrs at a time subject to fulfilling the other criteria. Other terms and conditions as mentioned in the O.M.s dated 19<sup>th</sup> Sept. 1990, 5<sup>th</sup> July 2005 and 2<sup>nd</sup> July 2012 will remain same.

4. This issues with the approval of the competent authority.
