

Invitation for Application for hiring of Professor in Arun Jaitley National Institute of Financial Management (AJNIFM) on deputation/re-employment basis

Arun Jaitley National Institute of Financial Management (AJNIFM) intends to engage a faculty at the level of (Pay Level-14) Professor on deputation/re-employment basis. Only professionals with requisite qualification and experience as prescribed in Annexure 'A' would be hired. Each applicant has to apply in the format as per Annexure 'B'. Completed application(s) may be sent to director@nifm.ac.in; or procurementtraining@nifm.ac.in. The details are as follows:

1. **Qualification:**

Essential/ Desirable qualifications mentioned in Annexure 'A'

2. **Roles & Responsibilities**

- (i) A Procurement Research Centre (PRC) has been established in AJNIFM in collaboration with Department of Expenditure, Ministry of Finance.
- (ii) The faculty to be engaged at the level of Professor (Pay Level – 14) will be the Head of the PRC and must bring in significant domain expertise to contribute to the research.
- (iii) Ensure timely completion of the research projects, sending quarterly reports to Department of Expenditure
- (iv) Organize a conference on public procurement each year with international participation. Two domestic seminar/ workshops on public procurement may also be undertaken, with the locations chosen by rotation.
- (v) Annually publish a comparison between Indian procurement standards vis-a-vis procurement standards in different countries. This will include analysis of areas of strength and weakness and lessons which can be learnt and other responsibilities of Procurement Research Centre (PRC).
- (vi) S/he will report to the Director, AJNIFM.

3. **Other entitlements/ Conditions:**

3.1 Remuneration

Remuneration will be given as per experience & qualification of the Professor (Pay Level-14). Payment shall be made monthly.

3.2 Tax deduction at Source

Income tax or any other tax, if any, as per prevailing rules, will be deducted at source before effecting the payment for which AJNIFM will issue a TDS certificate separately.

4. **Termination of Agreement:**

AJNIFM may terminate the services to which these terms apply if:

- (i) The Professor is unable to complete the assigned work within the prescribed duration;
- (ii) Quality of the assigned works is not to the satisfaction of AJNIFM;
- (iii) Professor fails in the timely achievement of the milestone as finally decided by AJNIFM;
- (iv) Professor is found lacking in honesty/ integrity; and
- (v) The job cannot be terminated by the Professor without giving written intimation.
