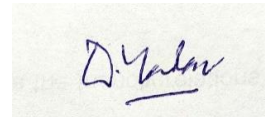

With the growing penetration of internet and digitalization, ensuring cyber security has become critical. The Ministry of Electronics and Information Technology (MeitY) launched the Cyber Surakshit Bharat Programme on 19th January, 2018 and has been organising deep dive training programmes to orient the government officers responsible towards security of the IT systems, familiarising them with the emerging challenges of cyber security and providing them with key inputs to take informed decision on cyber security related frameworks, policies, technologies and issues.

2. The training is meant for designated Chief Information Security Officers, Chief Technology Officers (CTOs) and members of technical teams, from Central and State Government Ministries/Departments and their subordinate offices, and PSU Banks and Insurance companies. Sixteen batches of training have already been conducted. Due to COVID-19 pandemic, it is proposed to conduct deep dive training under Cyber Surakshit Bharat in online mode. The online mode of training will start from 30th November, 2020. The brochure of the programme is attached herewith.
