

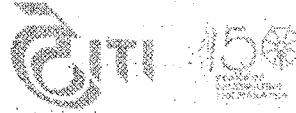



Sub: Deputation of officers from DoT, PSUs and Government Departments with Engineering background without immediate absorption to ITI Limited.

Ref: DPE letter F.No. 23(17)/2005 – GM Dated: 19.04.2018

ITI is executing many turnkey projects like MahaNet, GujaratNet&RajNet under BharatNet phase – II projects for providing high speed broadband connectivity to Gram Panchayats across India. Further ITI is also expecting ASCON Phase – IV project for Defence(Army) of around Rs.7000 Cr which is a mega turnkey project for establishment of OFC based communication network. The project spans for about 13 years.

ITI has recently participated in BBNL Wi-Fi project for which the bids have been opened recently wherein ITI has become L1 in 3 packages in Maharashtra and is the only bidder in 6 packages namely Assam, Chhattisgarh, Jharkhand, Kerala, West Bengal and Gujarat – II. The total expected value of the project is about Rs 3000 Cr For all these packages ITI needs to establish around 2 lakhs Wi-Fi hotspot.

The project also involves supply and installation of Radio links, maintenance of OFC. In addition to these ITI is expected to get some more packages under procurement quota for which we have received the CCEA approval recently. The project is of 5 years period and infrastructure is established by the bidder would be retained by the bidder for further period also.

BBNL Wi-Fi project is of National importance and the delivery period is around one year. In order to complete the project within time frame efficiently it is felt that the experienced officers in project execution needs to be deputed so that the projects will be completed fast within the time frame.

In this background you may kindly refer to DPE letter wherein DPE has agreed DoT proposal for Deputation of officers from DoT, PSUs and Government Departments with Engineering background without immediate absorption to ITI Limited. (A copy of the DPE letter is enclosed.)

Looking in to importance, complexity and duration of the BBNL Wi-Fi project, ITI would be requiring 2 to 3 senior officers (1) at the level of Executive Director (EDR) and (2) 5 to 6 General Manager (GM) Level for Bharat Net & BBNL Wi-Fi project execution on deputation basis initially for Three years.

It is requested that DoT may kindly process our request for deputation of 2 to 3 officers at EDR level and 5 to 6 at General Manager Level (GM) as sought above. The project wise requirement of Officials on deputation is indicated in the Annexure.
