

Dear Sir/Madam,

I am pleased to invite your organization to participate in the 9th World Telecommunication/ICT Indicators Meeting (WTIM), which will take place in Port Louis (Mauritius), from 7 to 9 December 2011. The meeting is organized by the Telecommunication Development Bureau (BDT) of the International Telecommunication Union (ITU) and hosted by the Information and Communication Technologies Authority (ICTA) of Mauritius.

The meeting will address, among others, the following topics:

1. Measuring broadband capacity, quality and speed
2. Measuring ICT sector investment, revenue and value added
3. Revisions to the indicators on household ICT access and individual ICT usage
4. Emerging issues such as measuring e-accessibility and e-waste
5. Results of the work carried out by the Expert Group on Telecommunication/ICT Indicators (EGTI) and launch of the ITU Handbook on infrastructure indicators.

The meeting, open to all the membership, is primarily addressed to those responsible for ICT statistics in relevant Ministries, regulatory agencies, telecommunication operating companies and national statistical offices. Experts interested in the subject of information society measurements are also welcome to attend the meeting.

Within the budget available, one fellowships per country may be granted to participants from countries with a GDP per capita of less than 2'000 USD, with priority to participants who will submit a paper of direct relevance to an agenda item. Due to budgetary constraints, the countries beneficiaries of a fellowship may have to contribute partly to the costs of the fellowship. Please note that both the paper and fellowship form must be received at ITU no later than **14 October 2011**.

Interpretation will be provided based on the requests of participants. You are therefore invited to indicate on the registration form whether you require languages other than English before **3 October 2011**. Based
