

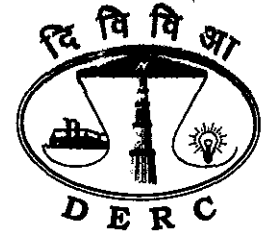

NOTE 1: For purpose of Column 9, the terms lease would mean a lease of immovable property from year to year or for any term exceeding one year or reserving a yearly rent, where however, the lease of immovable property is obtained from a person having official dealings with the Government Servant, such a "lease" should be shown in this column irrespective of the terms of the lease, whether it is short term or long term, and the periodically of the payment of rent.
