The content of sub-para (ii) to the para 1 of the said amendment may be read as under:

- ii. **The Licensee shall ensure that Metro Service Area of Delhi, Mumbai, Kolkata and Chennai are covered within one year of date of allocation of start up spectrum. The date of migration or date of allocation of frequency whichever is later shall be considered for computing a final date of roll out obligation. ”**

- ii. The Licensee shall ensure that metro service area of Delhi, Mumbai, Kolkata and Chennai are covered within one year of date of allocation of start up spectrum
