1. Code '1950' was allotted to Election Commission of India vide DoT Letter No. 16-3/09-AS.III/Vol.III/418 dated 13.06.2011 (Copy enclosed) for public grievance redressal as per request from Election Commission. In accordance with this allotment, by dialing this code one can reach a telephone number indicated by the Chief Electoral Officer of the respective state.
2. It is mentioned in the above mentioned DoT letter that this is a metered service (called-party pays) which means the Chief Electoral Officer of the respective state pays for this service to the TSPs.
