2.0 The Officers at Units in DoT shall perform the following functions and other functions as assigned from time to time:

- a. Inspection & Certification of Telecom/Postal Electrical Installations as per provisions of I E Rules 1956 & amended time to time.
- b. Implementation & Monitoring of RET deployment to Green the Telecom, and Phasing out Diesel from Telecom sector.
- c. Implementation of Energy Efficiency & Conservation standards/norms.
- d. Testing and Monitoring of Passive Infrastructure related works in projects carried out by DoT.
- e. Implementation & Monitoring of Renewable Energy Technology and Carbon Emission Reduction.
- f. Maintenance and upkeep of DOT installations (TEC Buildings, Wireless monitoring Stations, CCA/TERM cell units etc).
- g. Assessment Rent/Lease of Buildings.
- h. Execution and Supervision of various projects in DoT.



- i. Monitoring & restoration of service effectively – Mitigation of Disaster effects.
- j. Monitoring, Implementation of Environment Protection (Noise & Pollution) Act.
- k. Health related issues of EMF Radiation - Create awareness and disseminating the knowledge.
- l. Green Tribunal Cases
- m. Arbitration Cases, Audit paras, Complaints/VIP references, RTI matters etc.

3.0 The officers of P&T Building Works(Gr A) Service working in the field units shall be under the administrative control of the Head of TERM Cell State Units and Technical control with their respective discipline Heads.

4.0 The officers will be entitled for Travel Allowance etc. as per their eligibility.

5.0 Pay and allowances of the officers shall be paid by DoT Hq/TEC/respective co-located TERM Cells/NTIPRIT.

6.0 This issues with the approval of the competent authority.
