Subject: Writ Petition Nos. 25511/2005, 25531/2005, 26712/2005 and 12161/2006 filed by ITS officers before Hon'ble High Court of Andhra Pradesh in the matter of absorption of Group A officers in BSNL/MTNL – Orders dated 12.2.2014 passed by the Hon'ble Court.

The petitioners in the above writ petitions had challenged the order dated 31.10.2005 passed by CAT, Principal Bench in OA No. 1963/2005 and 16 connected OAs as also the terms and conditions of absorption incorporated in the first option letter dated 24.3.2005. In three of these writ petitions, viz. WP Nos. 25511/2005, 25531/2005 and 26712/2005, interim orders were passed by the Hon'ble High Court of Andhra Pradesh to the effect that there shall be interim suspension of the operation and implementation of the process of absorption of Group 'A' officers initiated by DoT vide option letter dated 24.3.2005 and the judgement dated 31.10.2005 of CAT, Principal Bench and all further proceedings—pursuant thereto including repatriation of the officers to their parent Department.

- 2. The above writ petitions have since been disposed of by the Hon'ble High Court of Andhra Pradesh by two separate orders dated 12.2.2014. As per these orders, all the 4 writ petitions have been disposed of in terms of the judgement rendered by the Delhi High Court dated 17.4.2012 in WP No. 22515/2005 and also subsequent orders, if any, passed by the Delhi High Court. In writ petition No. 26712/2005, the petitioners' counsel prayed to the Hon'ble Court to dismiss the writ petition in so far as the petitioner Nos. 10, 12 to 14, 23 and 26 are concerned. The Hon'ble Court accordingly dismissed this writ petition in so far as the said petitioners are concerned. A copy each of the common order passed by the Hon'ble Court in WP Nos. 25511/2005, 25531/2005 and 12161/2006 and the separate order passed in WP No. 26712/2005 is enclosed for information/ necessary action.
- 3. Attention, in this context, is invited to the following orders, among others, issued by DoT on 11.3.2013 in pursuance of the Cabinet decision dated 13.2.2013 in the matter of absorption of Group 'A' officers including ITS officers in BSNL/MTNL:-
 - Repatriation of all Group 'A' officers including ITS officers currently on deemed deputation to BSNL and MTNL with immediate effect subject to any interim/stay orders passed by High Courts/CAT Benches in certain cases filed by Group 'A' officers.
 - ii) Deployment of ITS officers in BSNL and MTNL for a period of 10 years on year-to-year diminishing basis as per their requirement plan on the terms and conditions approved by the Cabinet with effect from the date BSNL and MTNL relieve officers in pursuance of (i) above subject to any interim/stay orders passed by High Courts/CAT Benches in cases filed by Group 'A' officers.
- 4. As specifically made clear in the above orders issued by DoT, unabsorbed ITS officers working on deemed deputation in BSNL/MTNL in whose cases interim/stay orders passed by the Courts were in force were neither repatriated to DoT nor were they deployed in BSNL/MTNL on year to year diminishing basis in pursuance of the Cabinet decision.

5. Now that the interim orders passed by the Hon'ble High Court of Andhra Pradesh in the above writ petitions stand vacated, the orders issued by DoT dated 11.3.2013 become applicable to such of the officers who were petitioners in the matter before the Hon'ble High Court of Andhra Pradesh. Necessary orders may, therefore, be issued by BSNL and DDG (Establishment), DoT for repatriation of the concerned officers to DoT and their deployment in BSNL on year to year diminishing basis in compliance with the orders dated 11.3.2013.




