This has reference to this office letter No. 800-15/2010-VAS dated 27.08.2010 wherein it was mentioned in para 4 that "...for subsequent annual self certification, the certificates for which shall be submitted by 15<sup>th</sup> of November every year...". Further, vide this office letter of even no. dated 31.03.2011, the last date for submitting self certificates was extended from 15<sup>th</sup> November 2010 to 31<sup>st</sup> March 2011.

In this regard, it is to intimate that it has been decided by the competent authority that the frequency of self certification shall be after every two years in place of every year. Accordingly, the date of submitting the self certificate for next two year cycle shall end on 31.03.2013. The necessary amendment to licence conditions shall be issued separately.
