OFFICE MEMORANDUM

The issues relating to disbursement of pensionary benefits to all the combined service pension optee absorbed employees of Mahanagar Telephone Nigam Limited (MTNL) have been considered by the Government and the following has been decided:


- (a) Payment of pensionary benefits to all categories of the erstwhile employees of the Government (Group A, B, C & D) absorbed in MTNL who have opted for pension on combined service will be made by the Government in the same manner as in BSNL with effect from 01.10.2000. Accordingly, amendment to include the word "and Mahanagar Telephone Nigam Limited" after the word "Bharat Sanchar Nigam Limited" in the sub-rules 22 to 24 of Rule 37-A of CCS (Pension) Rules, 1972 has been notified by DoP&PW vide G.S.R. No. 138 (E) dated 03/03/2014 (Copy enclosed).
- (b) Government employees, who were absorbed in MTNL and drawing pension as per DoP&PW's OM dated 05.07.1989 have also been brought within the purview of these rules with effect from 01.10.2000.
- (c) The liability of the Government for the payment of aforesaid pensionary benefits shall be restricted to the amount arrived at by calculating pensionary benefits of MTNL absorbed employees based upon the equivalent pay-scales of similarly placed employees in BSNL. As most of the pay-scales in MTNL are higher than that of BSNL, the additional liability arising from the same shall be borne by MTNL, by making advance payment to the Government.
- (d) The arrangement as specified in para (c) above shall continue till next wage revision by which time MTNL and BSNL shall achieve pay scale parity by bringing down the pay scales of MTNL to the level of BSNL pay scales.
- (e) MTNL shall make pension contribution to the Government as per FR-116 as is applicable in the case of BSNL with equivalent BSNL pay scales.
- (f) MTNL shall make pensionary contribution as per para (e) above along with advance payment as indicated in para (c) above to the Government from 1.10.2000, which shall be adjusted against actual payment of pension already made by MTNL.

(g) The excess amount paid by the MTNL, determined as per para (f) above, shall remain with the Government, to be adjusted against future liabilities of MTNL towards the Government. This amount will not earn any interest.

(h) The mechanism of settlement including verification, payment of pensionary benefits, pension contribution and advance payment by MTNL towards its portion of liability shall be decided by DoT. Detailed instructions in this regard will be issued separately.

जा.क.वि. 186(अ).— राष्ट्रपति, संविधान के अनुच्छेद 809 के परंतुक और अनुच्छेद 148 के खंड 5 द्वारा प्रस्तावित शर्तों का प्रयोग करते हुए भारतीय लेखापरीक्षा और लेखा विभाग में कार्यरत कर्मचारियों की सेवा शर्तों के संबंध में भारत के विभिन्न और महालेखापरीक्षक से प्रभावित करने के पश्चात् केंद्रीय सिविल सेवा (पेशवा) नियम, 1972 में संशोधन करते हुए एतद्वारा निम्नलिखित नियम बनाते हैं—

1. (1) इन नियमों का अक्षिप्त नाम केंद्रीय सिविल सेवा (पेशवा) दूधत संशोधन नियम, 2014 है।
- (2) ये 1 अक्टूबर, 2009 से प्रवृत्त हुए जानें जाएंगे।
2. केंद्रीय सिविल सेवा (पेशवा) नियम, 1972 के नियम 37 का, में
  - (अ) उपनियम (22) एवं उप नियम (23) में जो भी अर्थ अर्थों से आते हैं 'भारत संघार निगम लिमिटेड' शब्दों के पश्चात् 'पूर्व महालेखापरीक्षा विभाग लिमिटेड' तथा संदर्भों में 'विद्यमान' शब्दों को 'पेशवा' शब्दों से प्रतिस्थापित किया जाएगा।
  - (ब) उप नियम (24) के खण्ड पर निम्नलिखित उप नियम रखा जाएगा अर्थात्—

"(24) उपनियम (23) के अंतर्गत ही यदि व्यवस्था विद्यमान पेशवा शर्तों तथा उन कर्मचारियों की लागू होगी जिन्हें भारत संघार निगम लिमिटेड और महालेखापरीक्षा विभाग लिमिटेड में अनेक के पश्चात् सरकारी सेवा से नियमित रूप से प्राप्त हुआ जाना पड़ा है और महालेखापरीक्षा विभाग लिमिटेड एवं भारत संघार निगम लिमिटेड द्वारा दी गई

भर्ती द्वारा नियुक्त हुए कर्मियों पर यह लागू नहीं होगी जिनके लिए वे स्वयं की पेंशन स्कीमों का उपाय करेंगे तथा उसके लिए निधिकरण तथा पेंशनिक फायदों के संवितरण की व्यवस्था करेंगे।”

#### NOTIFICATION

New Delhi, the 3<sup>rd</sup> March, 2014

G.S.R. 155 (E).—In exercise of the powers conferred by the proviso to article 309 and clause (5) of article 148 of the Constitution and, after consultation with the Comptroller and Auditor General of India in relation to conditions of service of persons serving in the Indian Audit and Accounts Department, the President hereby makes the

following rules further to amend the Central Civil Services (Pension) Rules, 1972, namely:-

1. (1) These rules may be called the Central Civil Services (Pension) Second Amendment Rules, 2014.

(2) They shall be deemed to have come into force with effect from the 1<sup>st</sup> October, 2000.

2. In the Central Civil Services (Pension) Rules, 1972, in rule 37A,—

(a) in sub-rule (22) and sub-rule (23), after the words "Bharat Sanchar Nigam Limited" in both the places where they occur, the words "and Mahanagar Telephone Nigam Limited" shall be inserted;

(b) for sub-rule (24), the following sub-rule shall be substituted, namely:-

"(24) The arrangements under sub-rule (23) shall be applicable to the existing pensioners and to the employees who are deemed to have retired from the Government service for absorption in Bharat Sanchar Nigam Limited and Mahanagar Telephone Nigam Limited and shall not apply to the employees directly recruited by the Bharat Sanchar Nigam Limited and Mahanagar Telephone Nigam Limited for whom they shall devise their own pension schemes and make arrangements for funding and disbursing the pensionary benefits."

#### EXPLANATORY MEMORANDUM

Provision of pensionary benefits to all categories of the erstwhile employees of the Government (Group A, B, C and D) absorbed in Mahanagar Telephone Nigam Limited who have opted for pension on combined service will be made by the Government in the same manner as in Bharat Sanchar Nigam Limited with effect from 1<sup>st</sup> October, 2000. Such erstwhile Government employees including those absorbed in Mahanagar Telephone Nigam Limited with effect from 1<sup>st</sup> November, 1998 and governed vide DOP&PW's O.M.No. 4/18/87-P&PW(D) dated 5.7.1989 shall be brought within the purview of these rules with effect from 1<sup>st</sup> October, 2000. This is certified by the Department of Telecommunication that no one shall be adversely affected by giving retrospective effect to this notification.
